



Dog Walking Contract

All parties hereby agree to the following stipulations below:

1 Reservations

This agreement becomes active upon the signatures of both the client and Alaska Paws and Paths and will continue until one party decides to end it. The client is welcome to request additional services via telephone throughout the contract period, depending on availability. All arranged visits will be bound by the terms outlined in this agreement.

2 Dog Walking

The fee for a single walking service is \$25 for 30 minutes for one dog, with an additional \$5 for each extra dog. For one hour, the fee is \$35 for one dog, with an additional \$7.50 for each extra dog. Clients may also purchase pre-paid punch card packages for convenience and savings, with pricing as follows: 10 Half-Hour Walks: \$220 for one dog. 10 One-Hour Walks: \$300 for one dog. Discounts apply for additional dogs as follows: For 10 half-hour walks: \$5 per walk for each additional dog. For 10 one-hour walks: \$7.50 per walk for each additional dog. All punch cards remain valid for a period of six months from the date of purchase. Dog walking services are available during typical business hours, Monday through Friday, from 8:00 AM to 6:00 PM.



3 Cancellations

Walks canceled within 24 hours of the scheduled service will incur a charge equal to 50% of the walking rate. To avoid this fee, clients must notify Alaska Paws and Paths through email, text, or phone call.

4 Behavioral Expectations

Full disclosure of all negative pet behaviors, including reactivity, bite history, resource guarding, etc., is required. Failure to disclose such behaviors will result in an additional charge of \$200 for the client.

5 Payment Timeframe

Client agrees to remit full payment for services outlined in this contract prior to the commencement of any work. Failure to make payment may result in a delay or cancellation of services. Once payment is received, Alaska Paws and Paths will initiate the agreed-upon services promptly.

6 Emergency Pet Care

All parties acknowledge that the well-being of the animal is of utmost importance. In the event that additional services are deemed necessary during the service period to ensure the proper care of the animal, Alaska Paws and Paths and its staff will make reasonable efforts to contact the client. Should the client be unreachable for any reason, Alaska Paws and Paths and its staff are authorized to take necessary steps, as determined in their reasonable judgment, for the health and welfare of the animal. Such steps may include but are not limited to: (a) Consulting with the client's designated veterinarian or an emergency veterinary care provider if the client's veterinarian is unavailable. (b) Undertaking any other actions deemed necessary or appropriate by Alaska Paws and Paths and its staff for the well-being of the animal. The client agrees to assume responsibility for all associated fees and expenses incurred for the care and treatment of the animal as outlined in this paragraph. The client releases Alaska Paws and Paths and its staff from any liabilities arising from transportation, treatment, or expenses incurred. Additionally, the client agrees to reimburse Alaska Paws and Paths for all incurred expenses, along with any applicable fees for attending to the animal's needs or for the procurement of necessary supplies.

7 Force Majeure Clause

In cases of inclement weather, natural disasters, or other unforeseen circumstances beyond our control, Alaska Paws and Paths and its staff are authorized to exercise their best judgment in ensuring the well-being of your pet(s) and home. Factors such as weather conditions and outside temperatures are carefully considered when scheduling walks for your pet. Should temperatures drop below 15 °F, or as deemed appropriate based on your dog's breed, a walk may be canceled. No charges will be applied in the event of such a cancellation. Alaska Paws and Paths and its staff shall not be held liable for any consequences resulting from these decisions.

8 Dog Walker Indemnity

Alaska Paws and Paths commits to delivering the agreed-upon services with reliability, compassion, and integrity. By accepting these services, CLIENT releases Alaska Paws and Paths and its team from any claims related to the service provision, except in cases of gross negligence or deliberate misconduct. In the event that Alaska Paws and Paths or any authorized personnel accompanying the dog walker or pet sitter incurs injury or harm while providing services, CLIENT agrees to indemnify and hold Alaska Paws and Paths harmless from any resulting losses or damages, except in cases of gross negligence or deliberate misconduct by Alaska Paws and Paths and its team.



9 Recommended Leash

The client acknowledges that Alaska Paws and Paths and its staff shall not be held liable for any consequences arising from the client's preference to have their pet walked off-leash, including situations where the pet does not return to the dog walker when called. This disclaimer extends to all potential outcomes, including but not limited to encounters with wildlife or other unknown entities during off-leash walks.

10 Vaccinations

Prior to receiving any services from Alaska Paws and Paths, all pets must have current and up-to-date vaccinations as required. Proof of vaccination must be provided.

11 Contract Termination

Either Alaska Paws and Paths or the Client may terminate this contract at any time by providing written notice to the other party. Alaska Paws and Paths shall be entitled to payment for all services rendered up to the date of termination, as well as for any necessary transition services required to ensure the well-being of the Client's pets. Alaska Paws and Paths and its staff will not terminate services during a scheduled service period unless the dog walker determines, at their sole discretion, that continuing the service poses a danger to the health or safety of the dog walker. In such cases, every effort will be made to promptly notify the client of the situation.

All parties acknowledge that by signing below, they grant written approval for services provided by Alaska Paws and Paths. Upon acceptance, Alaska Paws and Paths and its staff are authorized to enter the client's premises and conduct services without the need for additional signed contracts or written authorization. Furthermore, Alaska Paws and Paths is permitted to accept telephone reservations for future visits.
